# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to fundingpips.com, and governs data collection and usage.

FundingPips website is an eCommerce site. By using FundingPips website, you consent to the data practices described in this Statement and all extensions and addendums to this Statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, FundingPips may collect personally identifiable information, such as your:

If you purchase FundingPips products and services, we collect billing and credit card information. This information is used to complete the purchase transaction or issue payments to you. ## **Sharing Information with Third Parties**

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by FundingPips. This information is used for the operation of Page 3 of 5 services, to maintain the quality of the service, and to provide general statistics regarding the use of the FundingPips website.

#### Use of Cookies

FundingPips website may use cookies to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.
